AskColorado

Two more CoALL law libraries have joined AskColorado, the 24/7 virtual reference service run by the Colorado State Library (<http://www.askcolorado.org/>). Madeline Kriescher from the 10th Circuit Court of Appeals Law Library and Chris Hudson from the Colorado Supreme Court Law Library are now answering email referrals on general legal questions in addition to the University of Denver's Westminster Law Library.

The National Indian Law Library is also a specialized referral library. Other non-legal special libraries that participate are the CU Health Sciences Library, Denver Art Museum, Denver Botanical Gardens and National Snow and Ice Data Center. Most of the libraries and librarians included in the state-wide service are from public, academic and school libraries. AskColorado is funded through a combination of local contributions from Colorado libraries and federal funds provided by the Colorado State Library under the Library Services and Technology Act (LSTA).

AskColorado answers an average of 5000 questions a month. Over 350 library staff from Colorado libraries share the staffing responsibilities. At any given time, 2-5 librarians are online. Evening, weekend and specialized Spanish language services are contracted out to Tutor.com. AskColorado is designed to provide customized service to fit the needs of each user. Live AskColorado sessions can take 5 minutes or 25 minutes depending on the question, email referral questions generally get a response within 48 hrs.

We were both fortunate enough to be selected to participate in the 6th annual [TRIPLL](#) (Teaching Research in Private Law Libraries) conference put on by LexisNexis Library Relations Group this past April in Dallas, Texas. Along with 30 other law firm librarians we spent the weekend attending presentations, participating in breakout sessions, getting some hands-on practice with new technologies, and sharing our challenges and successes with one another. The theme, "It's a Brave New World—Reengineering Training for Today's Law Firm" neatly summarized the concerns the sessions addressed: how can we train our library users most efficiently and effectively?

We both came back to Denver energized from one of the best conferences either one of us had ever attended, and with lots of new ideas and techniques. We want to share just a few of these with you in this article.

Trends in the Industry

Cindy Spohr, Senior Director of the LexisNexis Library Relations Group, began the conference by giving us an overview of the legal industry. Some of the important points with regard to law firm libraries:

- Law firms are being managed more as businesses. They are increasing the number of C-level positions and filling them with non-lawyers. It is important to remember the focus on the bottom line.
- Talent Management (attracting, retaining and motivating high quality lawyers) is also a focus. Librarians can use their research and training skills to contribute to the overall program by selling ourselves as a benefit to the attorneys.
- Information overload continues to frustrate legal professionals. We can help by working with attorneys to deliver information in the format and frequency they prefer.

Different Learning Styles

Michael Saint Onge presented on the different learning types (auditory, visual, tactile) and generations (veterans, boomers, Gen X, and millennials). Some takeaways:

- When training, look for clues as to what type of learner (auditory, visual or tactile) you are working with, and respond with changes in your training style
- Have an agenda for a training session, but let the user change it to suit his/her needs
- When training over the web, keep checking in with your audience to get their input and to gauge their comprehension and interest (you can't see their puzzled looks or bored glances!)

Speak Smart

Kathy Kerchner gave some terrific pointers on public speaking. Best takeaway was on an answering technique called :

- Bridging – To take an off-point question back to the topic you want to talk about 1) acknowledge or briefly answer the question, then 2) bridge back to your

topic with a phrase such as “The real issue is”, “It’s more important to consider” “Another way to look at it” “What I’m more concerned about”, etc. Watch for this technique to be used frequently this year by campaigning politicians!

Technology Solutions

Cindy Chick presented one of the most popular sessions on using technology. There were so many takeaways, it’s hard to choose what to list here. Some of the highlights:

- Cindy demonstrated web conferencing, such as [ReadyTalk](#), and desktop sharing, such as Funk Software Proxy, as examples of how to show our users what we’re seeing, even if we’re not in the same room with them.

- By far the most popular tool demonstrated was [SnagIt](#). SnagIt is a screen capture software that allows the user to capture the image on the screen, then edit it by inserting arrows, highlighting or circling text, etc. Imagine the user guides you’ll create! SnagIt can also be used to create short videos that can be used to demonstrate how to use a product.

- Another favorite was [pbwiki](#), which allows groups to set up a wiki to share and edit information. We used a pbwiki to collaborate to write this article! The wikis are easy to set up and are password protected.



Marketing your contributions to firm success

Joanne Kiley gave us some pointers on how to market our libraries in her session entitled "Your Library Helps the Whole Business Succeed -- Market That!" Some "Rules" for marketing training sessions that Joanne shared with us include:

- Vary the communication avenue you use to gain more attention -- sometimes an email works, but next time try posting flyers around the firm or even use an old fashioned memo.
- Food attracts people (but works better on staff than attorneys) -- make the food seasonal or special to attract new people. Joanne shared her famous rum ball recipe with us, which she uses every winter to draw people into her library.
- Laminate User Guides and put them in the stacks near the resources they describe -- that way you’re marketing your services, even when you’re not there!

Does this make you want to attend next year’s TRIPL? The LexisNexis Library Relations Group will be soliciting applications early in 2009. If you are selected, all your conference costs will be covered by LexisNexis except for transportation to and from the conference venue in Dallas.

2008 Spotlight On Your Career: Travel Tips — Report

O n Saturday, February 23, 2008, the Colorado Association of Law Libraries (CoALL) and the Rocky Mountain Special Libraries Association (RMSLA) presented Spotlight on Your Career 2008: Travel Tips for the Road to Success. Made possible by a grant from the AALL/BNA Continuing Education Grants Program, this year's event featured two remarkable speakers. Kathy Stroh, an accomplished speaker, writer, and teacher with over 20 years of experience, presented "Juggling Master: A Hands-on Lesson Dealing with the Most Difficult Obstacle in Your Path to Success—You." Kim Dority, renowned author, teacher, and president of Dority & Associates, presented

"Putting Yourself in the Path of Opportunity."

The program attracted a total of 61 registrations. Most of the evaluations were positive. A summary is attached. [omitted]

The attached spreadsheet [omitted] provides financial details of the program. This year, RMSLA co-sponsored the program with CoALL, sharing equally with CoALL in any profits (or losses up to \$1500). This allowed the committee to hire keynote speakers, rather than using panelists to fill the program. The final figures showed a profit of \$58.28 for each of the associations. (The figures are not directly comparable from earlier years to 2008 because this year, for the first time, we made a conscious effort to include the value of items that were actually donated, such as the facilities.)

The full committee met for breakfast a few days after the program and made notes of suggestions for improving future programs. A copy of my notes from that meeting is attached. [omitted]

I also met earlier this week with Martha Campos and Wanda McDavid to discuss the future of the program in more detail. The three of us feel that CoALL should continue to support this effort because it does serve our goals of reaching out to library students and providing professional development for our members. However, we also feel that CoALL should move away from the lead and toward a supporting role for future Spotlight programs, while RMSLA, which serves all special librarians, should take the lead. This would free CoALL to use some of the volunteer hours and vendor donations that we have been pouring into Spotlight to produce a program aimed directly at law librarians or the people who hire them, while it would allow RMSLA to make the most of this professional development program for all special librarians. Finally, we feel that, whoever takes the lead in future programs, the pro-

Bridge the Research and Analysis Gap (BRAG) 2008

On Thursday, June 5, 2008, CoALL held its seventh annual Bridge the Research and Analysis Gap (BRAG) program. Attendees learned: the ins and outs of effective communication in regard to a research assignment; tips for using Casemaker; about Colorado-specific legal resources; how to conduct Colorado legislative history research; when to stop researching; and to be aware of one's internet footprint. Presenters included:

Stacey Bowers & JoAnna Patrick (Westminster Law Library, University of Denver); Alicia Brillon & Alan Pannell (University of Colorado Law Library); Andrea Hamilton (Faegre & Benson LLP); Margi Heinen (Sherman & Howard L.L.C.); Wanda McDavid (Access/Information); Holly Pinto (Holland & Hart LLP); Esti Shay (Westminster Law Library, University of Denver); and Mariann Storck (U.S. Attorney's Office). Attendees also received advice on making the most of their summer work experiences from James A. Pinto, Shareholder at Brownstein Hyatt Farber Schreck LLP.

There were 86 attendees, which included 70 paid attendees, 12 scholarship attendees, and 4 CoALL members. The total profit from this year's BRAG was \$ 2,136.23.

Sixty-two attendees completed evaluations. Forty-six respondents agreed and 14 strongly agreed that "This session gave me valuable information to better function in the law firm or court"; 33 agreed and 29 strongly agreed that "The presentation introduced me to new sources"; 40 agreed and 9 strongly agreed that "I feel more comfortable now about discussing an assignment with the person making the research request"; 31 agreed and 30 strongly agreed that "The program packet is useful"; and 30 agreed and 29 strongly agreed that "My research skills will improve now that I have attended this program".

The 2008 BRAG committee was comprised of Andrea Hamilton (Chair), Matthew Elisha, Margi Heinen, Alan Pannell, and Holly Pinto. Volunteers for this year's session included Catharine Cott, Megan Jens, Rachel Kuipers, Tamara Phalen, Caryl Shipley, and Ann-Marie Wills. The following organizations provided generous support: CLE in Colorado, Inc., LexisNexis Courtlink, The Colorado Lawyer, LexisNexis, and Westlaw.


President:

Nudge: Improving Decisions About Health, Wealth, and Happiness

Nudge looks closely at why people make the decisions they do...

The idea that minor details can have a major impact on people's behavior is at the center of this intriguing book, co-authored by Cass Sunstein, who will soon be the director of the Program on Risk Regulation at Harvard Law School.

Much like *Sway: the Irresistible Pull of Irrational Behavior*, and *Freakonomics*, *Nudge* looks closely at why people make the decisions they do, despite the less than advantageous outcomes that may result. Moreover, it also examines how the way an issue is presented can influence the ultimate outcome – whether in a positive or negative manner.



The authors explain how the “choice architects”, those who are responsible for creating the context of a particular scenario, can present a choice in such a way as to nudge people towards making the best decision.

For example, the authors cite an extreme case from the United Kingdom. Some employers there provide a retirement plan that calls for no deposits by the employee. The employer simply deposits money into the employee's account each month. The only requirement is that the employee sign up for the plan. Shockingly, only 51% of employees did so. Similarly, 30% of employees

in the U.S. fail to sign up for their company's 401K plan. Thaler and Sunstein propose that instead of forcing people to opt-in to such a plan by filling out forms, they should be forced to opt-out. This would have the effect of greatly increasing 401K enrollment, and contributing to workers' successful retirement in the process. Simply making 401K enrollment automatic is the “nudge” that people need to make a better decision.

Numerous other examples are given. From shopping for mortgages and student loans to the design of Medicare Part D (prescription drug coverage), Thaler and Sunstein take a closer look at the overly complicated situations we encounter in our daily lives and look for ways to nudge us towards making better decisions.

While not a book on the law, this is an engaging and amusing look into behavioral economics that would be a welcome addition to any library, law or otherwise.
