## High Noon on the Dusty Plains of Law Librarianship

Several CoALL members meaningfully participated in WestPac's\* annual

meeting, held September 16-18 in Estes Park, Colorado. To wit: Kathy Carlson (with her talented crew Jason Raymond and Jessica Rehbaum from the Wyoming State Law Library) organized and hosted the Old Western-themed event. AALL's Law Library Journal Article of the Year Award-winner Karen Selden presented research underlying the article she wrote with Georgia Briscoe and Cheryl Ray Nyberg on the relative merits of two specific locations for electronic resources: the library web page and the catalog. David Selden and Monica Martens described some of the breadth and challenges of research and collection development in Indian Law.

On Thursday night, the company was treated to live music, courtesy of the Law North of Crow Creek (Wyoming Supreme Court Chief Justice William U. Hill, Wyoming Department of Revenue Director Ed Schmidt, and Don Raske, Partner in Raske and Arnold, a prominent Cheyenne firm). Harmonizing beautifully, the Law North of Crow Creek shared a few originals: most humorously, an ode to ESPN, along with some fabulous renditions of British Invasion tunes. Buck Sterling of Gonzaga ably led the Microbrewery SIS on a tour of local pubs.

Chief Justice Hill began the educational program the next morning with an historical and political perspective on the State of Wyoming's transition to a circuit court system. Next, Judith Royster, Professor of Law and Co-Director, Native American Law Center at the University of Tulsa College of Law, shared background on the long-awaited revision of Cohen's Indian Law Handbook, due out this April. At Friday's luncheon, AALL Board Member Janis Johnston shared

AALL's big plans and new strategies for adapting to change. She stressed the value of communication between AALL and its chapters.

Colorado's LexisNexis Library Relations representative Julie Webster-Matthews (a.k.a. "Tiny Bubbles") brought along Michael St. Onge, one of her counterparts in California, and both graced the proceedings with wonderful good humor. The incoming President of WestPac, Angus Nesbit (from the University of Oregon's John E. Jaqua Law Library), was formally welcomed to his office. Friday night was a lavish, wine-soaked affair enlivened by a costumed, Westpac star-studded murder mystery. Kathy Carlson's husband Jerry was the deceptively genial Papa Vito, ultimately pinned for the crime.

Saturday's program wrapped up the conference with "Feng Shui for Your Workplace: From the Perspective of the Black Hat School," presented by Eiko Okura of Naropa University in Boulder.

## Cohen's Handbook of Federal Indian Law

Cohen's Handbook of Federal Indian Law - New Edition is on the Horizon

On September 17, I attended and spoke at the Western Pacific (WestPac) Association of Law Librarian's Conference in Estes Park. One of the speakers at the conference was Professor Judith Royster from the Native American Law Center at the University of Tulsa College of Law. Professor Royster, one of the editors for the update to Cohen's Handbook of Federal Indian Law was invited to speak about this classic book. As you may know, Cohen's Handbook of Federal Indian law is considered the most important treatise on Indian law. In her presentation, Judith provided an historical look at Indian law and the handbook from its first publication in 1942 to the last published edition in 1982. In addition, she provided a brief description of the changes to expect when the new edition is published by LexisNexis in April, 2005. Some of those changes include a preface written about Felix Cohen's wife who had a significant impact on the first edition, more topical areas covered, and of course, updated content based on legal developments since 1982. Indian law practitioners have been looking forward to an updated edition of the Handbook for years and will certainly want to purchase a copy when it becomes available in April.

## CyberCemetery

Dan Cordova was the presenter for the Professional Internet Searcher User Group's October 19<sup>th</sup> meeting. He led an interesting tour of CyberCemetery, wherein lie the published remains of dearly departed U.S. government agencies and commissions. It can be accessed at <http://govinfo.library.unt.edu/>.

Dan explained that Cathy Nelson Hartman, former head of the government documents department at the University of Northern Texas Libraries' Government Documents Department, and George Barnum, electronic collections manager for the Federal Depository Library Program, laid the groundwork for this site at a 1997 convention of the American Library Association.

The University of North Texas Libraries and the U.S. Government Printing Office, as part of the Federal Depository Library Program, created a content partnership to provide permanent public access to the Web sites and publications of defunct U.S. government agencies and commissions. In the quick-change world of the Internet, "here today and gone later today," this collection provides a final resting place for the websites and electronic publications of "deceased" U.S. government agencies and commissions. Some of the headstones are for the Advisory Commission on Intergovernmental Relations (ACIR); the National Bioethics Advisory Commission, and the Office of Technology Assessment. There's also the trove of materials on streamlining bureaucracy, left behind by then-Vice President Al Gore, whose "reinventing government"

initiative expired in early 2001 just weeks after his presidential bid did. These materials were mentioned in a statement given by Janis L. Johnston, Director of the Albert E. Jenner Memorial Law Library, in April 2004 to the Government Printing Office Oversight Committee. She praised UNT's CyberCemetery as one of a "handful of depository libraries [that] have partnered with GPO to develop web sites that enhance public access. . . . During the first month that the "Cybercemetery" was expanded to include the publications of the National Partnership for Reinventing Government (NPR), approximately 187,000 users accessed information from the NPR."

The Professional Internet Searchers User Group was formed in January 2002 by Access/Information to provide an informal networking and sharing opportunity. Members get together to discuss changes, innovations and problems associated with internet searching. President Dan Cordova called the meeting to order at 8:10 AM.

✓ Dan announced Mary Killoran's request that minutes of CoALL meetings be submitted to her electronically for inclusion in Scuttle.

**1. Formerly adopting our e-vote in favor of Kaye as VP**

Five board members were present for the revote to approve Kaye's election as Vice President: Katheryn Christnacht, Dan Cordova, Andrea Hamilton, Margi Heinen, Caryl Shipley. All voted in favor; no dissents.

**2. Programming/Kaye's survey results**

✓ Kaye's survey was conducted via Survey Monkey. Of the 56 total members of CoALL, 27 responded. *Please see results, Attachment A.*

Kaye highlighted some of the survey results:

✓ Question 1. What do you expect from your membership in CoALL?

26 (96.3%) responded: Meetings that educate.

24 (88.9 %) responded: Socialization with other law librarians. From additional comments submitted, Kaye interpreted this socialization to mean establishing connections for brainstorming purposes.

✓ Question 2. Of the expectations above, which have you been able to accomplish with your CoALL membership in the past year?

21 (87.5%) responded: Socialization with other law librarians.

14 (58.3%) responded: Meetings that educate

12 (50%) responded: An organization to list on my resume

✓ Question 3. Which of these is most valuable to you?

21 (80.8%) responded: Meetings that educate

✓ Question 4. How often do you attend CoALL meetings each year?

12 (44.4%) responded: Twice

✓ Question 5. If you don't attend CoALL meetings or educational offerings, it is because:

9 (37.5%) responded: Time

Board recognizes that CoALL librarians are busy with strong commitments in workplace

✓ Question 6. If a CoAll meeting was called to discuss a strategic plan for future endeavors, would you attend?

22 (81.5%) responded: Yes

Board thanks Kaye for her survey results and agree they will be useful for program planning for the year.

Kaye then posted the following questions to the Board:

✓ As always, vendors are willing to offer meetings to CoALL, but some concern was raised about this being our exclusive avenue for programming.

✓ It is agreed that the value of vendor presentations shouldn't be overlooked

Discussion then turned to a general discussion about programming for the upcoming year.

✓ Program idea: Presentation in response to Colorado Federal District Court moving to electronic filing. It was noted that CoALL used to offer more programming such as this. Additional programming ideas: Competitive Intelligence (Katheryn), International Law (Dan), Technology & Teaching Law (Caryl), and Collaborative Law/Bradford publication (Dan)

✓ Importance of non-vendor programs to address issues not answered by vendors.

✓ In support of vendor programming if presenting outside of vendor matter, i.e. A Lexis Librarian Relations rep offers a program on presentation skills. There is a reluctance, however, that CoALL rely on vendors for bulk of programming.

✓ Dan brought up the following priorities when offering a non-vendor program:

A. Pre-plan & pre-announce

B. Provide food

- ✓ The problem of finding a common time good for the majority of CoALL members was brought up.
- ✓ Bylaws dictate there must be at least four meetings/year. There is a desire to have one in Boulder and one at an alternative time (i.e. after work on a Friday, on a Saturday)
- ✓ Should look to RMSLA for creativity concerning times, locations, and presentation content. Caryl Shipley volunteered to attend RMSLA meetings & will explore a membership.
- ✓ There was a discussion to reintroduce the Institute programming. The Institute started with centering around legal research and were held on Saturdays at DU. Vendors then began to become involved which effectively brought an end to the Institute. Board was enthusiastic about the Institute and tentatively proposed an Institute date for February 2005. It was then wondered if the Board needed to prioritize between the Institute and BRAG. There was mention of a BRAG committee.
- ✓ There will be a future CoALL meeting to focus on programming. There is an emphasis, however, that programs be announced in advance, that an outline of upcoming events be provided and that they be scheduled on some sort of regular basis.
- ✓ There is independent planning of meetings going on; confusing to members and hard to schedule around. CoALL Board needs to take charge and organize. It is thought that Matt Elisha may be interested in chairing the Brown Bag sessions. It is also suggested that in order to avoid confusion, all emails for Brown Bag sessions should come from Kaye.
- ✓ Initial planning for holiday party. Kaye suggested creative venues such as Celestial Seasons, Ocean Journey, Comedy Works, or the Art Museum. It was noted that some of these creative venues may be expensive and may be restrictive as far as catering is concerned. Each Board member should think of some suggestions, and do initial research on them, and forward the results to Kaye. Tentative date of the holiday party: Thursday, December 9<sup>th</sup>, starting at 5 PM at the earliest. It is customary to hold a Board meeting before the party.

### **3. Setting dates for our required membership—we need four**

- ✓ October (program & general meeting), December (program & general meeting), April, & June (Corporation meeting)
- ✓ The District Court training will hopefully be scheduled for late October (last week, 3 PM?) at the courthouse for technology reasons and also so that the presenter doesn't have to present outside his/her element
- ✓ Plan for a program to occur between December 2004 and April 2005 (February Institute?)

#### **4. AALL chapter visitor**

Dan explored Board interest in planning an AALL chapter visit by an executive board member. There will be some CoALL expense associated with such a visit. There was initial support of such a visit and Margi suggested combining this effort with a strategic planning meeting. This visit and/or strategic planning meeting is tentatively set for April 2005.

#### **5. Treasurer's Report has been submitted electronically**

✓ Per Margi's suggestion—

The Treasurer's report is accepted by the Board with the following amendment to the last page, in reference to BRAG:

Special thanks to Holly Kulikowski of Holland & Hart for providing location, video, and personnel support for this program.

✓ *Treasure's report is attached, please see Attachment B.*

#### **6. Bylaws update**

✓ Katheryn let the Board know that Kelly Berg, an attorney with HRO, is assisting with the amending of the bylaws. The amendments are in response to the Association's change to a 501(c)(3). Kelly is performing this services on a voluntary basis and, thus, will not be paid; this will need to be noted in the Treasurer's Report.

✓ Questions arise as to whether liability insurance for the Association is due in October. Dan will contact AALL since the price per member should come from them.

#### **7. Web/Committee reports & issues**

✓ CoALL Web site needs to be updated with new names of officers, committee chairs, and members

✓ An email will be sent by Dan to listserv reminding members that dues are due and their name will be removed from the Website if they're not paid

✓ Per the suggestion of Erin Zak, it is proposed that Sergio send a "welcome" email to new CoALL members, to let them know their application for membership was received and to tie them over until introductions are made at the holiday party.

✓ It was proposed that the bylaws be amended to include term limits on Board members that do not currently have them imposed

- ✓ Some considerations were mentioned about the possibility of cross-training in areas such as Web design
- ✓ Reminder that the holiday party needs to include “thank yous” to new members, as well as current, busy members
- ✓ Dan has proposed the establishment of a “President’s Book” to be passed down to future Presidents. The book will include an outline of recurring events/duties, tips, notes, etc.

Meeting is adjourned at 9:30 AM.
