Prestatehood Legal Materials Professor Barbara Bintliff

I asked Barbara Bintliff if I could include some information about this new publication. She sent the following summary, and mentioned, by the way, that she will not be receiving royalties on any of this.

Prestatehood Legal Materials A Fifty-State Research Guide, Including New York City

and the District of Columbia (Volumes 1 & 2) will be available from Haworth Press this fall. It is a combination of text and bibliographies on every state, and includes the information needed to conduct legal research for each state during its years before statehood. Most chapters include brief overviews of state histories, from colonization to acceptance into the United States, in addition to listing bibliographic materials. Coverage generally includes information on which foreign countries controlled the laws of the various territories. This guide focuses on materials that are readily available to researchers.

The chapter on Colorado (chapter 6) starts with the many foreign jurisdictions that claimed parts of the state, beginning in the sixteenth century. It moves into the pre-Colorado Territory period, when extra-legal governments were common. Mining districts, claims clubs, peoples' courts, the People's Government of the City of Denver, and the Jefferson Territory (based in Denver) and the Idaho Territory (based in Central City) are described briefly. The actions of many of these extra-legal governments formed the basis for some of the Colorado Territory's laws, and found their way into the laws of the new state; some are still on the books today. Sources for drafts of the Colorado Constitution are identified, as are the earliest territorial laws and court reports.

If any of CoALL's members was a bibliography of current state legal materials, they could consider the following: Colorado Legal Resources: An Annotated Bibliography, by Robert C. Public Access To Government Information Award

Description:

A principal tenet of the American Association of Law Libraries is the right of equal access to information for all to ensure an informed citizenry and to promote a just and democratic society. Established in 1998, the Public Access to Government Information Award recognizes persons or organizations that have made significant contributions to protect and promote greater public access to government information.

Application Information

Public Access To Government Information Award

ELIGIBILITY

Recipients of the award may be any individual or organization. Members of the Washington Affairs Office of AALL are not eligible. Recipients need not be law librarians or members of AALL.

ADMINISTRATION OF THE AWARD

The Public Access to Government Information Award shall be jointly administered by the AALL Government Relations Committee and the AALL Awards Committee. The Government Relations Committee shall: advertise the award; solicit nominations for the award; review the nominations; and recommend from two to four nominees to the Awards Committee. The Awards Committee shall make the final decision from the nominees presented and notify the winner. The Government Relations Committee will handle subsequent publicity activities and any miscellaneous tasks that arise in the administration of the award.

JUDGING CRITERIA

* A contribution that significantly improves public access to government information, thereby increasing the public's knowledge about the workings of government. The award is given in accordance with AALL's mission to provide leadership in the field of legal information and to promote equal access to government information. The award will reflect this by honoring the achievements of those who have championed public access.

* The extent to which the individual or organization has had a positive impact on protecting and promoting public access to governmental information.

* The extent to which the effort advances the AALL mission and Government Relations Policy.

AWARD PROCESS

Nominations for this award are to be sent to Timothy L. Coggins, University of Richmond Law School, Richmond, Va., 23172, tcoggins@richmond.edu. It is preferred that the nominations be in

electronic format. A subcommittee of the Government Relations Committee will screen the nominations and recommend from two to four nominees to the Awards Committee, which will make the final selection. All selection materials will be forwarded to the Chair of the Awards Committee.

A subcommittee of the Awards Committee, including the Awards Committee chair, will review the nominations and make a final decision on who will receive the award. Each nominee shall be considered individually and confidentially and will be judged according to the criteria listed above. Sources of information for the subcommittee about a candidate include the nominating letter(s) and recommendation(s) from the Government Relations Committee. To ensure confidentiality, contact with members of AALL other than the person(s) nominating, other Awards Committee members and Government Relations Committee members should be avoided.

Frequency and number of awards: The Award may be presented annually, but there is no requirement that the award be given each year.

Deadline for nomination: Nominations must be submitted to Timothy Coggins no later than February 1, 2006, to allow the two committees ample time to complete their deliberations and the administrative aspects of the award by April 15.

AWARD PRESENTATION

The award shall be presented during the AALL Annual Meeting, and it will be given in the name of the Association. It will consist of an appropriate memorial to honor the achievements of the individual or organization.

Board Meeting
August 16, 2005, 5:00 p.m.
Colorado Bar Association**

Board members in attendance: Kaye Waelde (President), Martha Campbell (Immediate Past President), Tom Seward (Vice-President/President-Elect), Shannon Vicic (Secretary), Jennifer Hammond (Treasurer), Ann-Marie Wills (Member at Large)

President Kaye Waelde called the meeting to order at 5:10 p.m.

Treasurer Jennifer Hammond provided a report on the chapter's finances (see the full treasurer's report attached to the end of the minutes).

In addition, Jennifer proposed that each year the treasurer change the lock on the chapter's post office box when he or she takes office. When the lock is changed, two new keys are issued, which would ensure that the treasurer and another board member have a key to the box.

The only drawbacks to changing the lock would be the cost (\$11 per year) and the additional paperwork required of the new treasurer. The board members agreed that those drawbacks were minor and asked Jennifer to change the lock on the post office box this year, with the practice to be continued by future treasurers.

After the treasurer's report, Kaye asked the board about the types of professional development programs that should be offered during the coming term. In particular, she inquired about the status of the CoALL Institute. In a recent membership survey, several members expressed interest in having the Institute revived.

Vice President Tom Seward reported that he sent an e-mail to members soliciting volunteers for the Institute and five members have expressed their willingness to help plan the institute.

He will begin working with those five members on the preliminary planning for the event. He said that he expected the Institute to be smaller in scale than it has been in past years. Several board members offered ideas for potential seminar topics for the Institute.

Kaye reported that the CoALL board has the opportunity to request a visit from AALL president Claire Germain in 2006, and she asked board members whether they were in favor of inviting the president of AALL for a visit.

Kaye and Past-President Martha Campbell discussed the cost of the visit and whether the cost would be financially burdensome on the chapter, since chapters usually are expected to shoulder the cost of meals and accommodations for the president.

The board members also discussed whether planning the BRAG program, the CoALL Institute, and a visit from the AALL president in the same year would tax the volunteer resources of CoALL.

However, Jennifer mentioned that a couple of student members of CoALL had expressed particular interest in helping coordinate a visit from Claire Germain; Claire is an alumna of the University of Denver.

Kaye suggested the possibility of combining Claire Germain's visit with the Colleague Connection. She reported that she had spoken with the presidents of the Colorado Library Association, the Rocky Mountain Special Libraries Association, and the Colorado chapter of the Medical Library Association, and they told her that they would be willing to provide financial assistance for Claire Germain's visit if she could be engaged to speak at the Colleague Connection.

Martha noted that if the president of AALL is unable to visit Denver due to a scheduling conflict, another executive officer may be sent in her place, and the other library associations might not be willing to provide financial support for anyone other than the president.

However, the board felt that it would be worthwhile to invite the president of AALL regardless of whether the chapter could count on financial assistance from the other library associations.

Tom Seward moved that the board invite the president of AALL to visit Denver, and Martha Campbell seconded the motion, which was unanimously approved. Kaye said that she would request that the president visit in April 2006 with the hope of being able to coordinate her visit with the Colleague Connection.
