Redesign of the CoALL Website

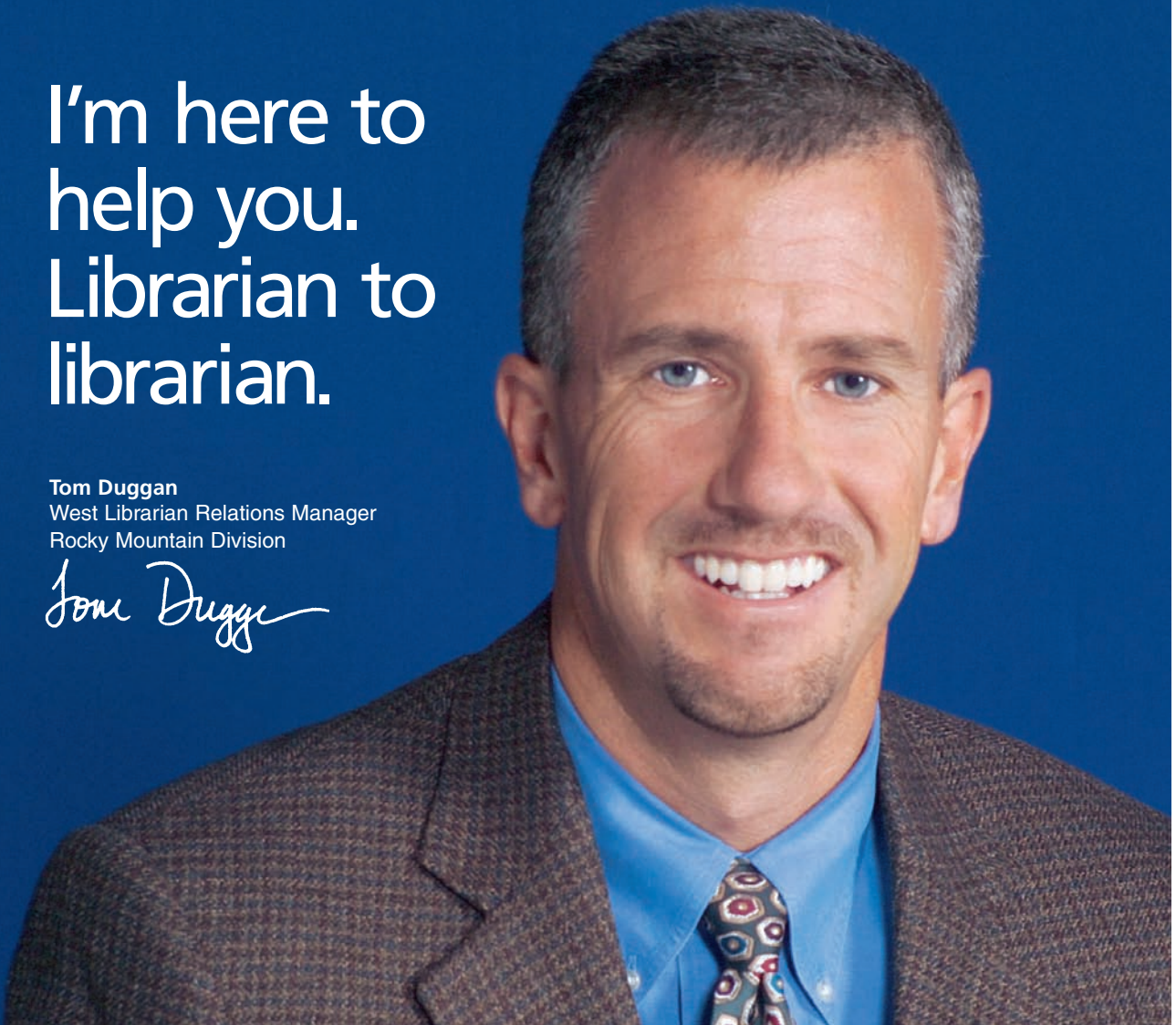

We Don't Mean to BRAG, but...

On June 1st, 2006, CoALL held the fifth annual Bridge the Research and Analysis Gap (BRAG) program in the Hershner Room of the Wells Fargo Building. BRAG committee members—**Goldie Burton, Martha Campbell, Matthew Elisha, Andrea Hamilton, Margi Heinen, Holly Pinto, and Mariann Storck**—felt the content presented was the best to date and attendees seemed to agree.

Mariann Stork moderated the event, which included these presentations: “The Research Assignment” (presented by **Margi Heinen**); “Your Organization’s KM” (**Matthew Elisha**); “Cost Effective Research” (**Holly Pinto**); “Bridging the Gap: Colorado and Secondary Legal Resources” (**Alan Pannell**); “Colorado Legislative History” (**Andrea Hamilton**); “When to Stop Researching” (**Holly Pinto**); and “My Experience as a Summer Clerk” (**Kwali Farbes, Sherman & Howard LLC**). New to this year’s schedule was “3 Research Questions”, which aimed to apply the content of the day’s presentations to actual research questions. Based on what they had learned during the course of BRAG, attendees were asked to share how they would start work on hypothetical research projects, such as, “What is the definition of the phrase ‘in order to’ in contracts situations?” and “I have this old Colorado statute; does it still exist? If yes, what is the current version and citation?”

Eighty-six people registered for the program, eighteen of whom were CoALL members and able to attend at no cost (this included the presenters), and nine summer associates/clerks attended on scholarship (no

registration fee was paid). Four people purchased program materials without registering for the session. After expenses, BRAG deposited over \$2000 in the CoALL treasury.

Supreme Court Justice Helps CoALL Celebrate New Law Building, Members Present Paper and Win AALL Award

The Colorado Association of Law Libraries (CoALL) celebrated the dedication of the new Wolf Law Building at the University of Colorado on September 8 in a ceremony featuring Supreme Court Justice **Stephen Breyer** and CU Law alumnus **Karen Mathis**, current president of the American Bar Association. The new law library will be the most comprehensive and technologically advanced in the 12-state Rocky Mountain region. Board Meeting
June 29, 2006, 4:45 p.m.

Departing board members in attendance: Kaye Waelde (President), Tom Seward (Vice-President/President Elect), Shannon Vicic (Secretary), Ann-Marie Wills (Member at Large), and Theresa (Tracy) Leming (Member at Large).

Newly elected board members in attendance: Tom Seward (President), Karen Selden (Vice-President/President Elect), Goldie Burton (Secretary), and Nancy Sensel (Member at Large).

COALL members in attendance: Andrea Hamilton, Mariann Storck, Rachel Kuipers, Tom Duggan, Holly Pinto, and Theresa Baker.

Kaye called the meeting to order at 4:45 p.m. She began by announcing the election results of the recent COALL election. The following board members have been elected to serve on the COALL board:

Tom Seward, President
Karen Selden, Vice-President/President Elect
Goldie Burton, Secretary
Jennifer Hammond, Treasurer
Nancy Sensel and Matthew Elisha, Members at Large

After introducing the new board members, Kaye expressed her deep thanks to the COALL members who served on committees and/or the executive board during the previous year. Kaye cited the Casemaker project, the Legal Research Corner columns in *The Colorado Lawyer*, the Spotlight and BRAG programs, the Scuttle, the COALL web site, and the public relations efforts of COALL as some of the successful endeavors of the organization over the course of the past year.

Kaye turned over the meeting to Tom Seward, the new president of COALL. Tom thanked Kaye for serving as president and presented her with a gift on behalf of the board. Kaye noted that she didn't volunteer to serve as president of COALL for recognition or gifts but rather because she thought that COALL could accomplish a great deal during the course of the year and that the efforts of the organization could make a positive impact on the community.

Tom shared the treasurer's report with those attending the meeting. Afterward, he introduced an idea from Tracy Leming regarding forming a downtown caucus for COALL members. This group would meet for lunch once a month at various downtown locations.

Mariann Storck and Tom Duggan discussed downtowners groups in which they had participated in Wisconsin and Minnesota. Mariann noted that the downtowners group in Wisconsin sometimes held formal programs and sometimes simply brought librarians together for "go-round" sessions during which attendees would introduce themselves and then bring up any issues of interest, such as vendor billing, filing, or more intellectual topics. The responsibility for hosting the lunches shifted from firm to firm so that planning the lunches wasn't too much of a burden on one person or firm. Attendees brought their own lunches, and the sponsoring firm provided desserts and beverages.

Tom Seward expressed his concern that he would lose Tracy Leming's participation in other areas if Tracy coordinated the downtown lunches. He offered a compromise in which Tracy would work with the brown bag committee on programming, including helping to coordinate downtown lunches for COALL members.

Ann-Marie Wills noted that she liked the idea of spreading the responsibility for planning the events to the hosting firms. Tracy offered to send an announcement to the listserv to see which firms would be willing to host.

Tom Seward also announced that he has some committee openings that he needs to fill and would be soliciting volunteers for those committees. He noted that he will be sending out an e-mail before the next COALL meeting to recruit committee heads.

Nancy Sensel asked for those attending the meeting to introduce themselves and everyone in the room gave a brief introduction.

Kaye asked if anyone at the board meeting was going to the American Association of Law Libraries (AALL) annual meeting and if they would be interested in getting together for an iced tea during the meeting. Tom Duggan encouraged those who planned to attend AALL to sign up for the dine-arounds that will be held during the conference.

Tom Seward discussed the agenda for the next general meeting. He would like that meeting to serve as an AALL wrap-up where members who attend can provide reports on their conference activities and experiences.

Tom reported that BNA is willing to donate \$300 for the next COALL meeting for catering. The next meeting will be held during the first week of August. One possible venue for the event is Bogey's at the City

Park Golf Course, as it has free parking and enough parking to accommodate the members who would be attending.

The board discussed some possible dates and times for the August meeting, which will be used to map out the agenda for COALL for the following year.

The board discussed the current status of the bylaws revision project. Kaye asked whether the board needs to look at the bylaws closely and make sure that they in fact need to be changed.

The bylaws were being worked on pro se by someone at Holme Roberts & Owen but that person is no longer with the firm, Kaye noted.

Holly Pinto said that the bylaws needed to be changed because the organizational status of COALL had changed and the bylaws needed to be updated to conform to the change in status. It has been 5 years since the organization's status changed, she noted.

Kaye said that the board may need to set aside a specific amount of money and hire an attorney to revise the bylaws.

Tom Seward asked whether COALL qualifies as a 501(c)(3) organization and whether anyone has the determination letter regarding the change in status.

Holly replied that COALL decided to change its status when the state changed the law regarding nonprofit organizations.

Kaye noted that the board might want to check with AALL to see if they have sample bylaws and whether they have attorneys who can handle changing the bylaws. Holly said that COALL could also check with the local bar regarding attorneys who might have experience working on the bylaws of a nonprofit organization.

Tom Seward asked Holly for an update on the status of the ALA salary survey.

Holly said that the committee took the definition of librarian that was provided in the original survey and refined it to include an MLS or JD educational requirement and more analysis for research.

The committee approved those revisions and forwarded those to the survey representative at Holme Roberts & Owen in April. The survey will be sent out in July. Holly said that the committee's goal was for the survey to be more reflective of the differences between librarians and other library staff members.

Holly said that she would follow up with Mark Estes to see whether the committee's refinements were included in the survey that was distributed.

Holly also discussed the BRAG program. The BRAG committee had a meeting about what worked and what didn't work at this year's program. The meeting was based on the feedback that this year's attendees provided. The BRAG committee should be able to tweak the program based on that feedback so that next year's program runs even more smoothly than this year's event, she said.

Holly announced to the board that the COY holdings are no longer listed in FirstSearch. Holland & Hart and Holme Roberts & Owen were paying for those holdings to be listed in FirstSearch, and since those holdings were out-of-date and inaccurate, they decided that it was not worthwhile to continue listing them.

Holme Roberts & Owen's holdings will be available through FirstSearch, and Holly said that Holland & Hart's holdings will probably be made available on FirstSearch eventually.

Karen Selden said she thought it would be useful if something were posted to the listserv letting members know that the COY holdings are no longer available, and Holly said that she would post an e-mail to the listserv regarding the removal of the COY holdings.

The meeting adjourned at 5:45 p.m.

Matthew Elisha (Member at Large), Nancy Sensel (Member at Large), and Tracy Leming (PR Chair).

President Tom Seward called the meeting to order at 4:35.

Reports from the Treasurer, and from the Membership and Spotlight Committees, were heard first and are appended to these minutes. Tom is going to check with Tamara Tureson, Membership Chair, to quantify and discuss possible reasons for the lapsed memberships.

Kaye is going to give the CoALL banner to Tracy to keep for use at events. Kaye gave the President's CoALL mailbox key to Tom.

The Board discussed the Spotlight program for 2007, to be held at DU's College of Law on Saturday, February 24th, in particular the desirability versus possible risks connected with Tom's proposed RMSLA collaboration. The discussion included the additional possibilities of collaborating with SWALL and PLL-SIS. No decision was made on this issue. The theme for this upcoming (2007) Spotlight is "Spotlight on Your Career: Communication."

Per Matthew Elisha, former BRAG committee member, Andrea Hamilton is heading up the BRAG committee this year. BRAG is planned for the first Thursday in June and is looking for new committee members.

Brown bags are off to a good start. Tracy Leming reported that 15 people registered for the first one. The benefits of these meetings to the membership may justify some degree of financial support from the Association (the Click U programs cost around \$99 each). In connection with this possibility and the many related issues, the Board voted unanimously to form an Ad Hoc Committee on Financial Planning composed of Treasurer Jennifer Hammond, Matthew Elisha and Goldie Burton.

An AALL Legislative Letter concerning funding for the GPO and addressed to Senator Allard was presented to the Board for signature by Scott Matheson, CoALL's Legislative Liaison to AALL. Before signing it on CoALL's behalf, Tom will follow up with Scott who may use the AALL Legislative Liaison Office for an opinion on whether an organization filing under 501(c)(6) can endorse anything remotely political.

Planning for the next Colleague Connection is underway.

The Board discussed the benefits of sending someone to the American Conference of Legal Administrators, as well as those of setting up and staffing a table there with information about CoALL. Tracy will research the cost of the above alternatives.

The Holiday Party is scheduled for December 7. Karen, Goldie and Nancy will revive, as much as possible, the planning committee from last year. Karen has already secured the location in the new CU Law School Building.

Several people expressed a wish to have an informal (but planned) CoALL meeting at next year's AALL, possibly at one of the giant Westlaw or Lexis events where it's easy to go without seeing a familiar face.

The question was raised: should we sponsor a VIP for AALL this year? In the past, CoALL sponsored Justice Hobbs. Tom suggested that we all consider possible candidates after the meeting and share them with the CoALL Board at our next meeting.

With the Board's approval, Karen will check with Ann Meyers, an AALL Executive Board Member, on her willingness and availability to visit our chapter in April.

Introductions of those present: New Member Alicia Brillon (CU Law), Jennifer Hammond, Tracy Leming, Tom Seward, Karen Selden, Matthew Elisha, Goldie Burton, Nancy Sensel, Kaye Waelde, and Mark Estes.

The Colorado Indian Bar Association's Red Rock Scramble run/walk is this Sunday, October 1, in Lyons, Colorado. David Selden is the contact for information including how to register.

Karen shared her experience at AALL this past July in the Leadership Training. She found it very valuable. Many practical topics were discussed, including specific vendors that offer AALL special rates on their goods and/or services, e.g., Marriott Properties and Survey Monkey. Other topics included: marketing programs, conducting a needs assessment, choosing a speaker, being an effective speaker and evaluating programs. The training also presented many networking opportunities.

Karen also reminded us of some key changes in AALL. The annual conference is going to be a day shorter, starting in 2007. The opening reception will be Saturday night, with programs on Sunday, Monday and Tuesday. Only one keynote speaker, only one AALL business meeting and no association-wide luncheon will be scheduled.

AALL has set aside \$25K in seed money to support regional programs.

AALL offers training for chapter treasurers and for the chairs of public relations committees, membership committees and government relations committees. Karen recommends that anyone in one of these positions attend the AALL training.

After the Library of Congress announced it would stop doing serials control, AALL sent a letter expressing its disappointment. AALL received a personal response from Deanna Marcum, Library of Congress Associate Librarian for Library Services, acknowledging our concerns.

Kaye Waelde attended a program at this past AALL conference that she enjoyed called “Emotional Intelligence”. She praised the speaker and described the program as very revealing and interesting.

A discussion on competitive intelligence followed. Mark Estes recommended a website to those interested in learning more: www.scip.org
