Happy New Year!! I hope 2002 was good to you and 2003 will be even better.


This month I want to point out all the volunteer and educational opportunities that will be available in 2003 from CoALL.

Stephanie Bents from Pikes Peak Library District contacted CoALL in December, and we have now agreed on two tentative dates for training: Friday, February 28th (10-12noon) and Friday, March 14th (8-10 AM or 8-12noon). They are a staff of 20 (wellversed in business, not-for-profit and general reference work), who inherited a legal collection of approximately 8,000 volumes. The collection apparently includes USCA/USCS and a wide variety of Colorado materials. Update on CoALL Website and Listserv

Greetings:

Here is a report on the CoALL Website and Listserv since Sep. 2002:

- * AALL's servers were hacked and rendered inoperative for several weeks during Sep. and Oct. 2002, making the CoALL Website and Listserv inoperative. Service was restored on Oct. 25, and has been consistent since. Due to backups, CoALL did not lose any data during these service interruptions. The Listserv Manager created a private e-mail forwarding list for CoALL Members, to facilitate CoALL email communication when the CoALL Listserv did not work.
- * The CoALL Website features three new pages:
- -- "Find the Law" with links to legal research pages created by Supreme Court Library, 10th Circuit Library, CU Law, and DU Law;
- -- "Legal Research Corner" describing the new CoALL column in The Colorado Lawyer, providing an e-mail hotlink for submitting research questions, and linking to the first "Legal Research Corner" column - many thanks to Mariann Storck and her LRC team for developing the content of this page;
- -- "Library Catalogs" with links to the catalogs of Supreme Court Library, HRO Library, NILL, CU Law, and DU Law - many thanks to Patty Wellinger for suggesting the idea for this page, and to the directors of these libraries for giving us permission to link to these catalogs.
- * Members-Only Section: We have created a Members-Only Section of the CoALL Website, password-protected, housing the Member Directory and the Union List.

- * The Fall 2002 issue of *The Scuttle* has been added to the CoALL Website; thanks to Mary Killoran for her work on this;
- * Updated CoALL Web Pages: the "Upcoming Events" and "CCR Info" pages have been updated.
- * Thanks to Caryl Shipley and Dan Cordova for their cooperation regarding adding new members' information to the listserv and the Web-based CoALL *Member Directory*;
- * The Website's pages have been backed up;
- * There are now 122 subscribers to the CoALL listsery;
- * We have not been able to obtain usage statistics for the CoALL Website, but we are working on it.

CCR Committee

In June 2002 the CoALL Executive Board asked the CoALL CCR Team to gather accurate information about the transition in publishers for the *Colorado Register/Code of Colorado Regulations* (CCR), and disseminate this information to CoALL's members. - * Martha Campbell has forwarded input from CoALL members about improving the CCR, to the new editor of CCR at Weil Publishing;
- * Katheryn Christnacht has written an article about the CCR publisher transition for *The Scuttle*:
- * We obtained confirmation from West Group that West intends to maintain the current version of CCR on WESTLAW;

* We updated the "CCR Info" page on the CoALL Website, to keep users informed about access to the CCR, and have linked to the excellent "Legal Research Corner" article about CCR.

PATRIOT Act National Teleconference

On December 11, 2002, the American Association of Law Libraries, the American Library Association, Association of Research Libraries, Medical Library Association and Special Libraries Association cosponsored a satellite teleconference, "Safeguarding Our Patron's Privacy: What Every Librarian Needs to Know About the USA PATRIOT Act & Related Anti-Terrorism Measures.

The speakers included Tracy Mitrano, Policy Advisor and Director of the University Computer Policy and Law Program for the Office of Information Technologies at Cornell University; James Neal, Vice President for Information Services and University Librarian at Columbia University; Gary E. Strong, Director of the Queens Borough Public Library; and Thomas M. Susman, a partner in the Washington office of Ropes & Gray.

The conference covered the basics of the USA PATRIOT Act, the FBI Guidelines and Homeland Security Legislation, the implications for libraries and the need for every library to have reviewed its policies, protocols and procedures.

CoALL Executive Committee Meeting Minutes Date: September 19, 2002. Location: Holland & Hart LLP in Denver, Colorado.

Attendees: Martha Campbell, Dan Cordova, Mark Estes, Mary Killoran, Druet Cameron Klugh, Holly Kulikowski, Monica Martens, Rob Richards, David Selden, Karen Selden, Mariann Storck.

Holly Kulikowski called the Executive Committee Meeting to order at 4:00 pm.

I.Minutes from the June 19, 2002 Executive Board Meeting were approved. II.Old Business

- A. Shall we become a member of the Colorado Association of Libraries? The Board's concern is that a position taken by CAL may differ from that of our Association; and, would we pay dues as associate members? Holly Kulikowski will contact CAL about both of these issues. If CoALL is not included as globally when policy issues are publicized, we would become a member.
- B. Prez Group meeting
- 1. Training opportunities include Advocacy campaign from CAL(handout included after the minutes); marketing workshop by the Colorado Library Marketing Council to be held in February or March, 2003
- 2. Marsha Rodney of RMSLA needs help with the next Colleague Connection which is usually held in March or April each year.
 - 3. Other Organization news
- a. CCML is considering an online members directory and a developing education program
- b. RMSLA has an open membership meeting in September (Return on Investment)
- c. RMSLA & ARMA have a joint program planned for October. It will be a panel discussion on treatment and policies in special libraries, law libraries and records departments. The panel will be composed of individuals from each type of organization.
- d. RMSLA has a November program composed of vendor reps. It will be held at the Rocky Mountain News Library
- e. RMSLA is planning another Colleague Connection for Spring, 2003.
- f. CAL is examining the feasibility of publishing a joint membership directory. They are considering paper versus the Internet. The benefits would be a directory by name, by topical speciality and by institution.

CoALL's position on this directory is that we support it in principle but cannot support it financially. Our concern would be currency, cost of production, cost of printing and confidentiality issue

g. CAL has a conference scheduled for October. Their membership total is 1235: 936 individual, 108 institutional, 8 cop (????) and 183 (???)

- C. CoALL's twenty-fifth anniversary celebration is scheduled for October 23rd at DU school of Law from 5:30 8 p.m. in the faculty forum. Both Lexis and Westlaw are supporting it. Committee members are Gaye Roesch, Cathy Eason, Martha Campbell, Monica Martens and Karen Selden. Invitations will be extended to current, past and lifetime members. The celebration will honor people and there will be an opportunity to contribute to a memory book which will be distributed art the Holiday party.
- D. Holly Kulikowski attended the Mile High Association of Legal Support vendor event. Holly thinks it would be a good idea to staff a CoALL table at next year's vendor event which takes place in August.

II. New Business

- A. The Esquire Group is a legal hiring service / placement agency. It places both permanent and temporary staff. Is this a resource for CoALL?
- B. Access Information has a brown bag program scheduled for ???. It is \$35 and the topic is disaster planning which is an ALA program. ALA offers monthly programs on timely issues
- 1. They are also offering a virtual research service which allows research by individuals with the Access Information consultants available for virtual assistance.
- C. CoALL needs several questions answered regarding a WestPac/CoALL joint conference for October 2004
 - 1. How many people generally attend
 - 2. Does WestPac usually put on joint conferences
 - 3. How many WestPac members are there
 - 4. What expectations does WestPac have of CoAll's members
 - 5. Does the date conflict with the CAL conference?
- 6. Both Holly Kulikowski and Barbara Bintliff have expressed an interest but these issues must be clarified first.
- D. A discussion regarding whether the CoALL directory should be password protected ensued. It was suggested that for privacy issues, it should be password protected. Second, members should be given the option to be listed electronically or not; third, AALL and many chapters are password protected or are in the process of adding a layer of protection. It was moved and seconded and agreed upon that the CoALL membership list be password protected. Rob Richards indicated that he will change the password quarterly.
- E. Colorado Lawyer column has been submitted. It was written by a committee made up of Martha Keister, Wanda McDavid, Mariann Storck, and Shannon Vicic. It is titled "The Legal Research Corner" and will be published quarterly. The first column addresses the Colorado Code of Regulations and the Colorado Register.
- F. Does CoALL need to have a Speakers Bureau?
 - 1. It's on our bookmark
- 2. Dan Cordova volunteered to head a committee to explore member areas of expertise and generate a list.
- 3. This bureau would be another forum for marketing our association and profession plus it may generate some fees or honoraria which our treasury could use.

- G. The CoALL committee on the Colorado Code of Regulations has submitted a report on its activities and is now dissolved. The committee was composed of Martha Campbell, Katheryn Christnacht, and Rob Richards. An article will be written for Scuttle.
- H. Dan Cordova and Martha Campbell will make a 3 hour presentation at Mesa State College in Grand Junction on October 14. The topic is Basic Legal Research. \$100 is being paid for their services.
- I. Holly Kulikowski accepted a One-Time Development Award at the 2002 AALL conference on behalf of CoALL.
- J. Mary Wilder scholarship issue was discussed. It was mentioned that other group chapter awards are not usually named after individuals except maybe after the 1st president of the chapter. The topic was tabled to the next meeting.

The Executive Board meeting was adjourned at 5:32 p.m.

Katheryn Christnacht and Martha Campbell volunteered to assist Rob with this committee. Rob will post updates to CoALL's Listserv as he finds out more.

I.) Membership Committee Report 2001-2002 Caryl Shipley

CoALL's current membership is 87, down from 105 last year. 33 of our members (38%) work in private law firm libraries. The number of members in academic libraries is 25 (29%) of the membership. Court and government library members number 14 or 16% of the membership. The remaining associates are lifetime members (5), people who work for vendors (6) and special libraries (2).

Nine new members joined CoALL during 2001-2002 and they were recognized and welcomed at our Holiday Party in December. Lifetime memberships are held by Lois Calvert, Frances Campbell, Al Coco, Oscar Miller, and Jean Tarbel.

Dues were \$20.00 for institutional, individual and associate memberships and \$5.00 for student memberships. This amount is prorated for those joining after January I and they need only pay \$10.00. Student dues remain at \$5.00.

Many CoALL members also belong to other library associations. 62 (71%) belong to the American Association of Law Libraries (AALL). 16 (18%) to the Southwestern Association of Law Libraries. 17 members (20%) to the Special Library Association (SLA), three members (3%) to the Colorado Library Association (CLA), seven members (8%) to ALA, one member belongs to the Wyoming Library Association, and one member belongs to WESTPAC.

J.) Publicity Chair/AALL Chapter Liaison Annual Report CoALL Business Meeting June 20, 2002

The focus of this position is to publicize CoALL and CoALL activities, as well as promote the accomplishments of CoALL and CoALL members, to appropriate interested parties within AALL, among the greater library community, and among the general public.
